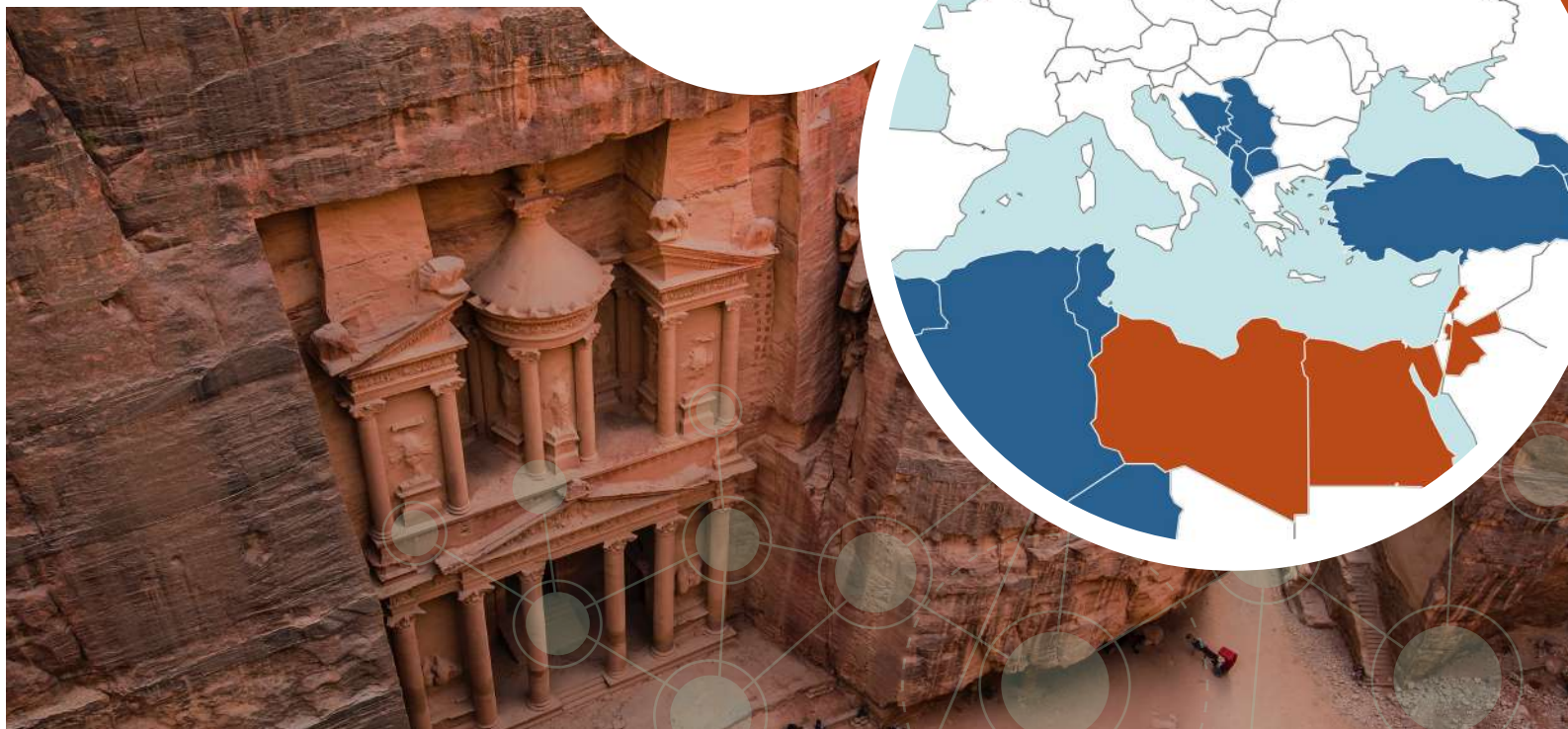
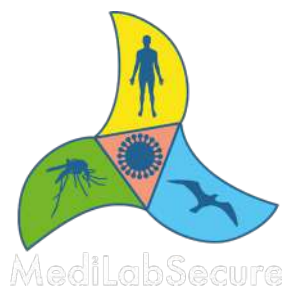

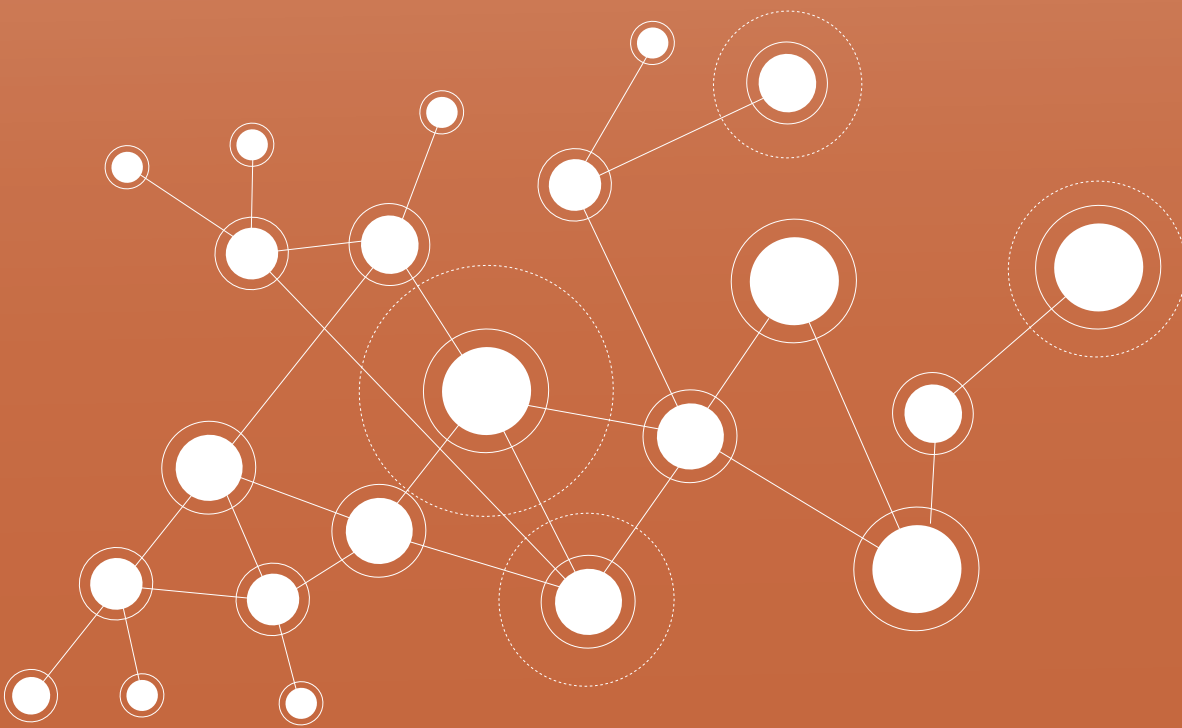

# Foreword

Your Excellencies who honour us of participating,  
Dear MediLabSecure partners, and contributors,

On behalf on the MediLabSecure consortium, it is our great pleasure to welcome you to this 3-day onsite meeting within, and for the Middle East Region.

Following the COVID-19 pandemic, there have been several scientific calls for the world to be better prepared for the next pandemic. Indeed, COVID-19 highlighted the need for a sustainable approach to surveillance and response to public health threats. Therefore, the successful implementation of a «One Health» approach seems crucial more than ever to enable an effective coordination between all national health sectors involved in prevention and preparedness activities.

Simultaneously, Anne-Sophie has worked as a biological threat technical expert in the framework of CBRN Initiative for EU Centers of Excellence.

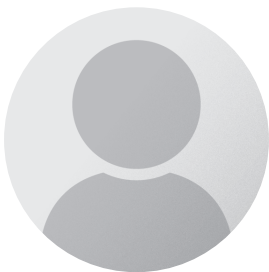

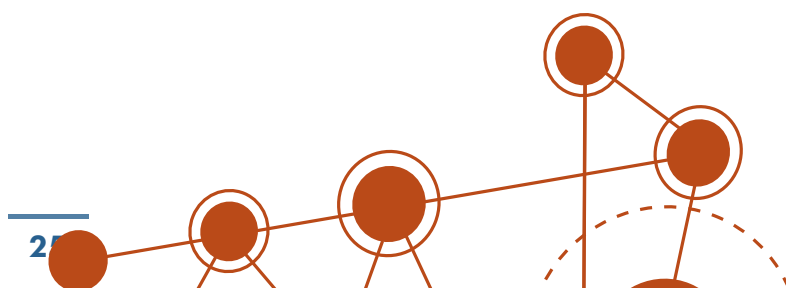
Dr Vincent Robert is the Work package leader of the medical entomology working group of the MediLabSecure project. He is Research Director at the French National Research Institute for Sustainable Development, in Montpellier. His speciality is medical entomology and human diseases transmitted by mosquito vectors, with a primary interest in malaria and arboviral diseases. He belonged to the team that, for the first time, demonstrated the huge entomological impacts of pyrethroid impregnated bednets against anopheline mosquitoes and malaria transmission. He published more than 250 articles in international peer-reviewed journals (h=33) and book-chapters, plus two books."

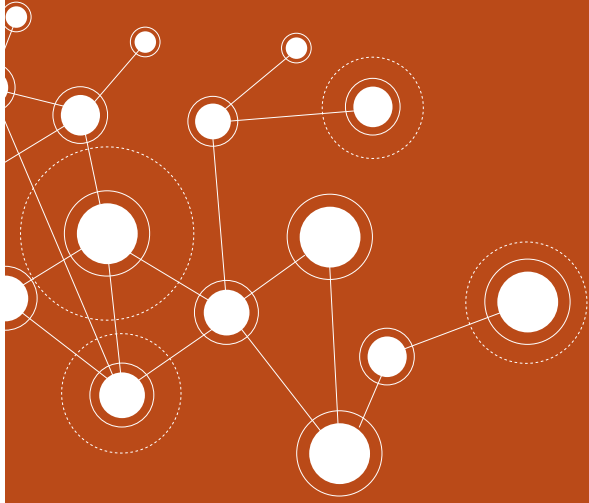

## Transport Shuttle - Visa

### Arrival : Shuttle

Upon your arrival in Jordan, a shuttle will pick you up from the airport and will take you directly to the Mövenpick Resort & Spa Dead Sea, where the accomodation and the meeting will take place.

*The driver will be waiting for you at the "Arrival" area of the airport with a sign indicating **MediLabSecure**.*

For the return trip, a shuttle will take you to the airport. Shuttles will be organized depending on the time of your return flight.

Regarding guests that will not be coming via plane, a private bus departure will be organized. This shuttle will arrive directly in front of the Hotel.

*Taxi costs for participants not willing to use the hotel shuttle won't be covered by MediLabSecure project and will be supported by the participants.*

### Visa

Some of you may need a Jordanian visa to enter the territory once you land or arrive in Jordan.

For the European nationalities, the visa is required once you land in the Queen Alia airport and will cost around 40 JOD. This visa can only be payed with Jordanian dinars in cash.

## Free and Extra Expenses

On the time of your arrival at the Queen Alia airport, your living expenses will be taken care of by the MediLabsecure funds. This includes :

- Breakfast, Lunch and Dinner from the 16th to the 19th of May. Most of the meals will be taken in the Hotel. Any meal taken outside of the scheduled hour or the registered restaurant will be at your own expense. The only meal outside of the Hotel that will be taken care of will be upon your arrival and departure, most likely near the airport.
- Once you arrive in the Hotel, you will have a 24/7 access to free Wifi connexion. It is recommended that you use this connexion to communicate, especially to people outside of the country, as the calls from the telephone in your room will be at your own expense.

## Per Diem & Reimbursements

In order to be reimbursed for your expenses before and after your presence in the Hotel, you should be keeping receipts in order to receive reimbursements. You will have to fill a document and send it to Overcome, the company that is taking care of a lot of logistical aspects of this meeting. These expenses include :

- Meals taken at the airport
- Travel fees from your personal home to the airport (Taxi, Bus, Metro, Uber)

## COVID-19

As you know, the COVID-19 crisis is still an important issue that must be taken into account while we prepare this meeting. The following measures are greatly recommended for the safety of everyone.

- Custom-made washable masks will be given to everyone. Wearing them in close confined spaces, such as elevators, meeting rooms and corridors is advised but not enforced.

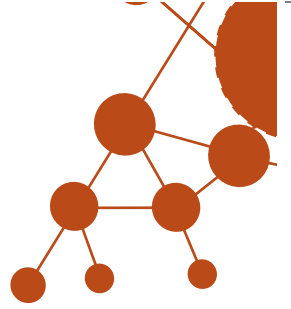

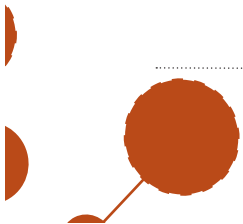
